Evaluation Design

Evaluation Questions

The evaluation of the working group was both formative and summative in nature, in that the data collected from participants was intended to both gain feedback from participants about the quality of the current working group and also to inform future meetings. Several questions constituted the foundation for the evaluation:

- 1. Were participants satisfied with the working group overall?
- 2. Did the meeting meet participant expectations?
- 3. Do participants feel the working group made adequate progress toward its stated goals?
- 4. Do participants feel they gained knowledge about the main issues related to the research problem?
- 5. Do participants feel they gained a better understanding of the research across disciplines related to the working group's research problem?
- 6. What impact do participants feel the working group will have on their future research?
- 7. Were participants satisfied with the accommodations offered by NIMBioS?
- 8. What changes in accommodations, group format, and/or content would participants like to see at future meetings?

Evaluation Procedures

An electronic survey aligned to the evaluation questions was designed by the NIMBioS Evaluation Coordinator with input from the NIMBioS Director and Deputy Director. The final instrument was hosted online via the University of Tennessee's online survey host mrInterview. Links to the survey were sent to the14 working group participants on December 7, 2011. Reminder emails were sent to non-responding participants on December 15 and 19, 2011. By January 3, 2012, 12 participants had given their feedback, for a response rate of 86%.

Scale: -2 = "Strongly disagree" to 2 = "Strongly agree"





Figure 2. Satisfaction with working group accommodations

Comments about understanding research in other disciplines:

Definitely. The fact that researchers from various behavioral and mathematical disciplines could clearly see structural parallels and common points and that communication was mutually so enriching was one of the strongest aspects of the meeting. Neither terminology nor any technicalities posed real problems, in the opposite, it was clear that different conceptual approaches can complement each other and thus strengthen our understanding of play.


I felt that because the participants came from different research areas, we were all committed to making it work. And I was impressed at how well this worked, especially for the first meeting.

I was surprised at how much progress was made. It didn't seem possible at the end of day 1 because the research we discussed was so diverse, but somehow (alchemy?), by the end of day 2, we managed to develop a common conceptual framework with clear ideas about how to proceed. I was struck by how every member of the group seemed interested in playing [with ideas] in a way that fostered cooperation -- coincidentally (perhaps), this is also one of the main issues we decided to pursue.

Most Useful Aspects of the Meeting

Being introduced to the data available in this area.

Bringing experimenters and theoreticians together.

For the first meeting, it was most useful just having us all there together to discuss and collaborate.

Free intensive discussion for such a long time, about only one topic "play".

It was incredibly useful to have people from so many different research perspectives and to together converge on one topic. It was extremely productive and interesting!

Meeting people interested in one topic, but having experiences from different fields, in one room and discussing during several days.

Most important was the opportunity to have two and a half day for working together within a unique group that brought together top play behavior researchers with top experts in modeling of behavior and evolution. With no formal tasks, we could focus of combining our ideas and expertize. We got personally acquainted to each other's' research topic and methods. Through brainstorming we identified two big questions we will work on and set up specific small teams to work on concrete tasks. For me, the three most important outcomes are: 1) We gained an invaluable comprehensive insight into the state-of-art of current play behavior research programs and mathematical modeling in the field. This effect would be impossible to achieve in any other way. 2) A specific collaboration was started. 3) An information network was established between the group members that will greatly enhance possibilities to exchange ideas and combine skills and thus start new lines of research.

Comments about influence on future research:

Absolutely. The immediate effect is that I will work till the next meeting on a specific modeling task with another group member (Jeff Schank). Moreover, the communication within the group, both during the meeting and after it through email, has strengthened my motivation and sharpened my focus on several other research tasks in both theoretical and empirical play research.

I know better what it is that my models should capture.

It helped me to see what might be most important in the sea of findings that I've been working with and also helped me to consider new possibilities for my future research.

It's an area ripe with low-hanging fruit. Lots of hard-won and fascinating data but few proper phylogenetic analyses.
